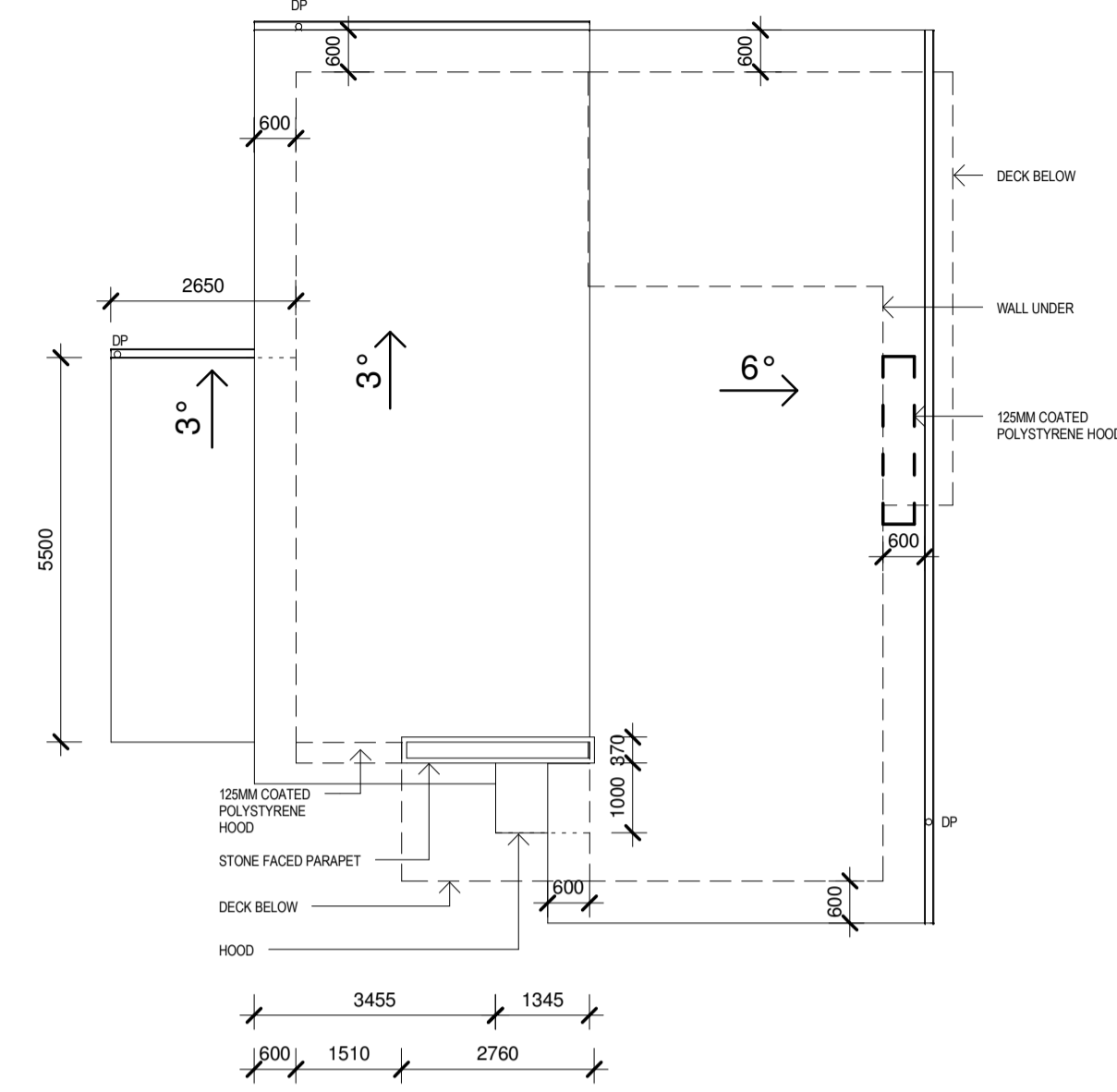
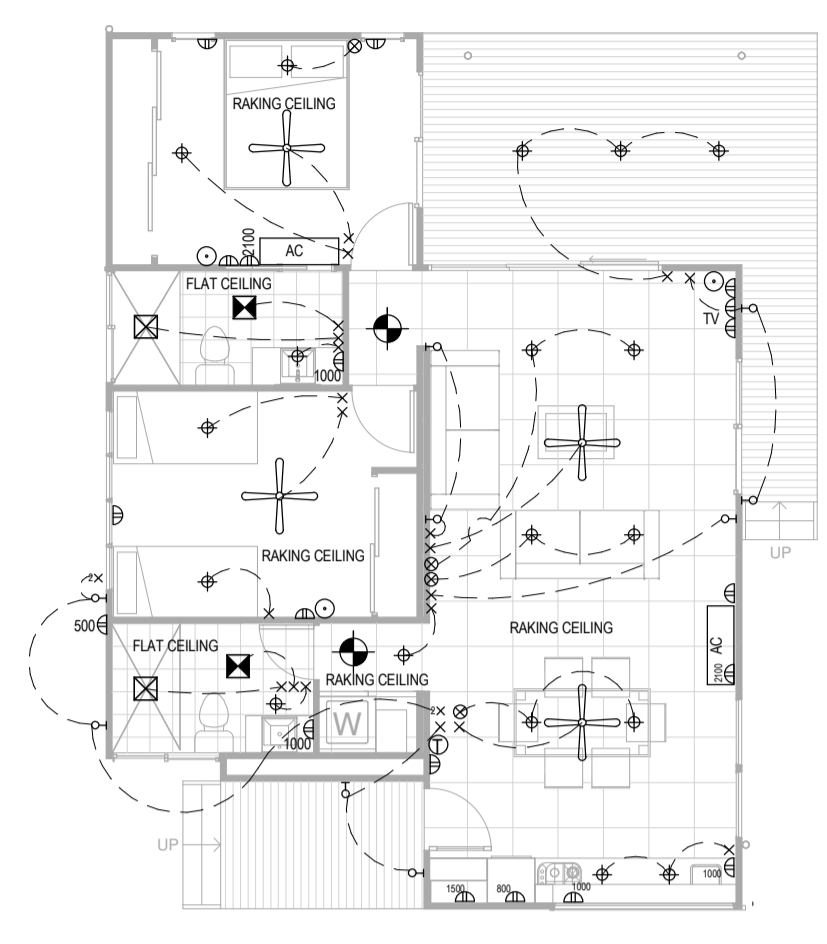


1 FLOOR PLAN

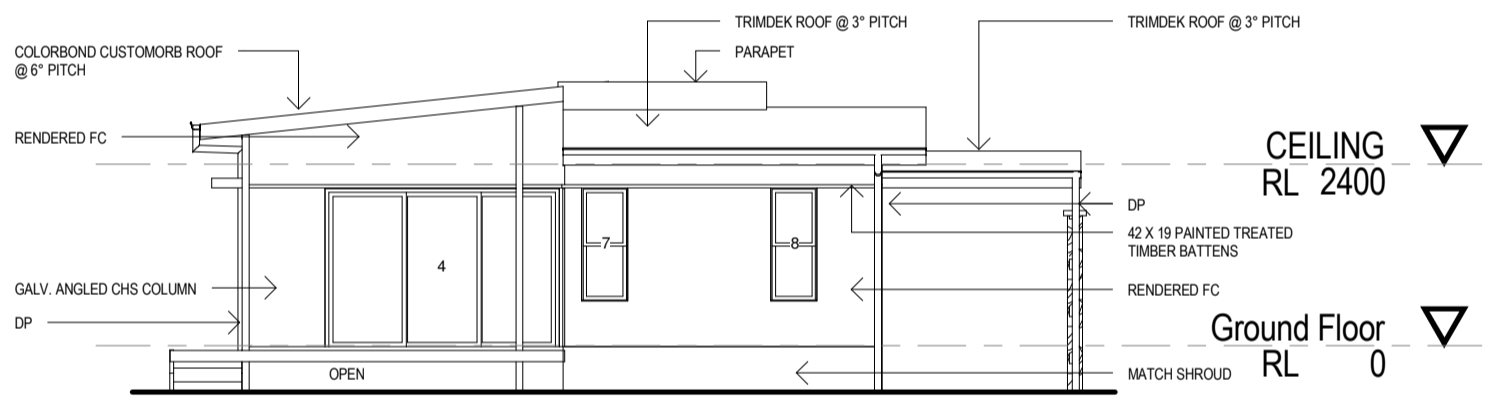
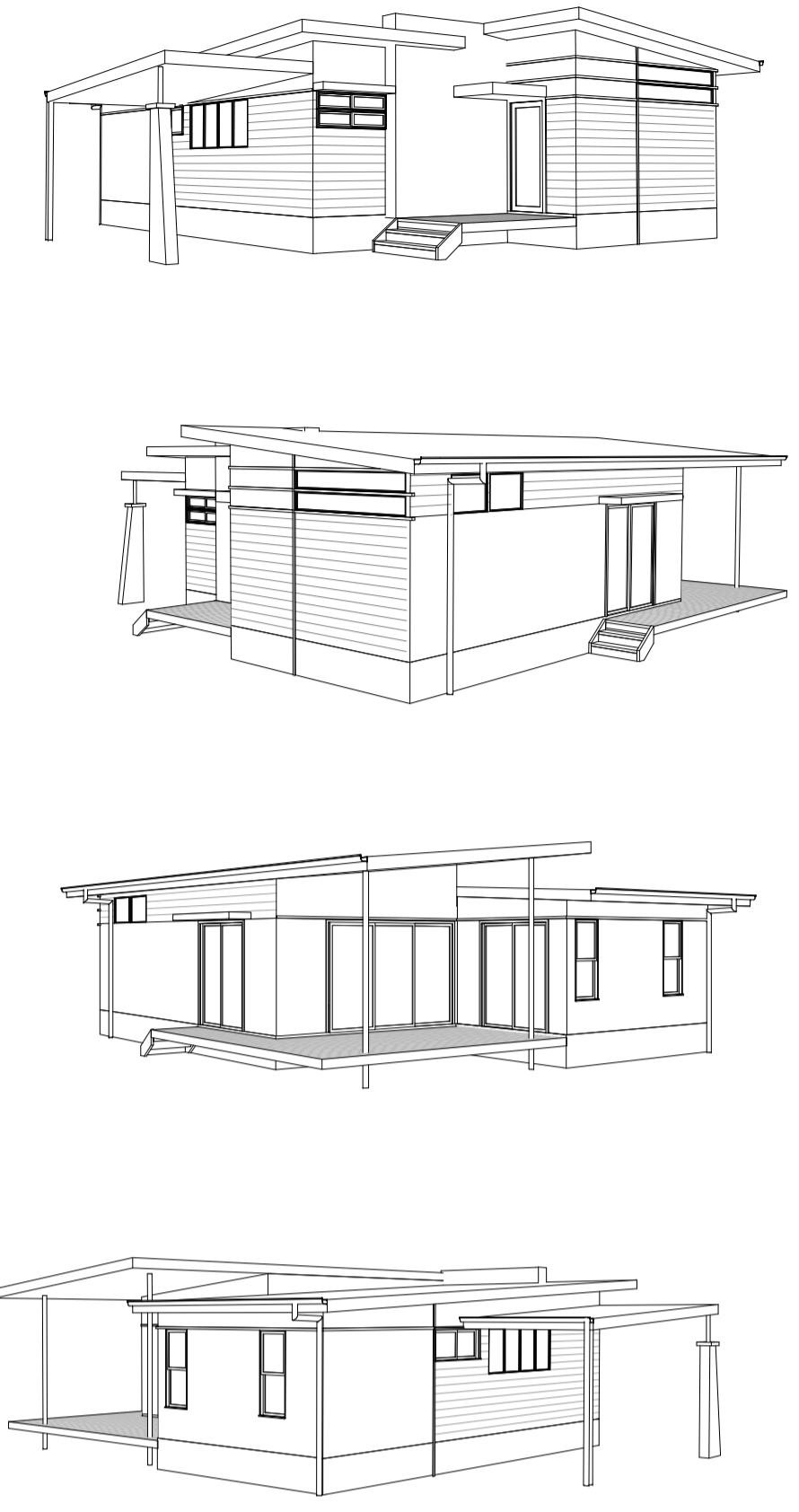


3 ROOF PLAN

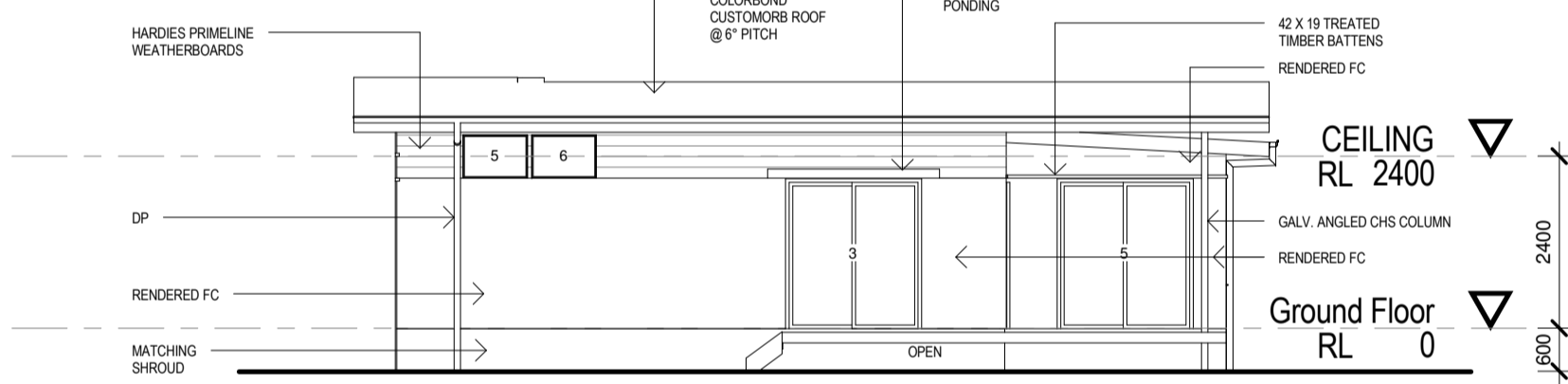

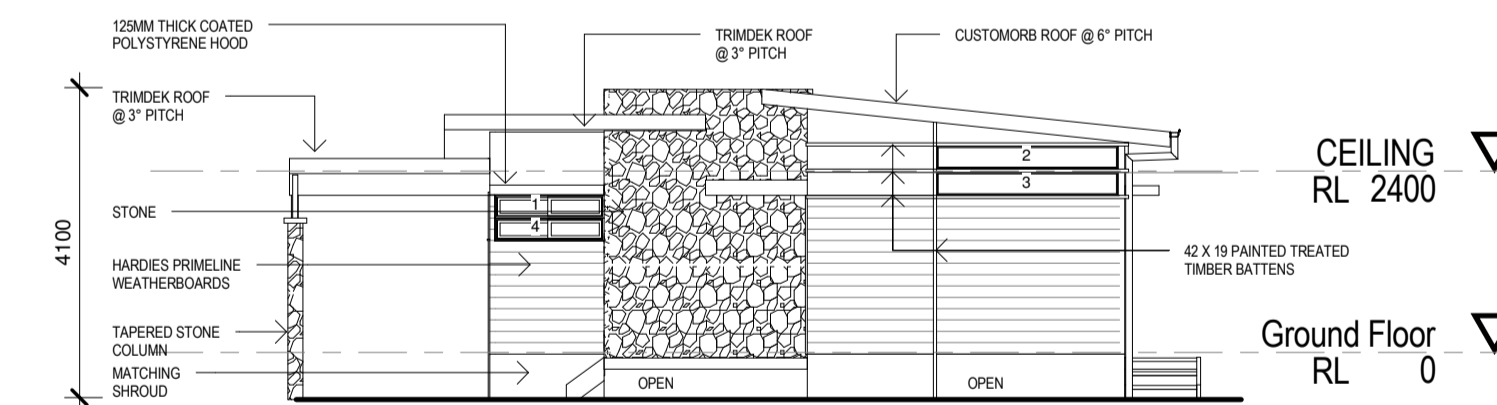

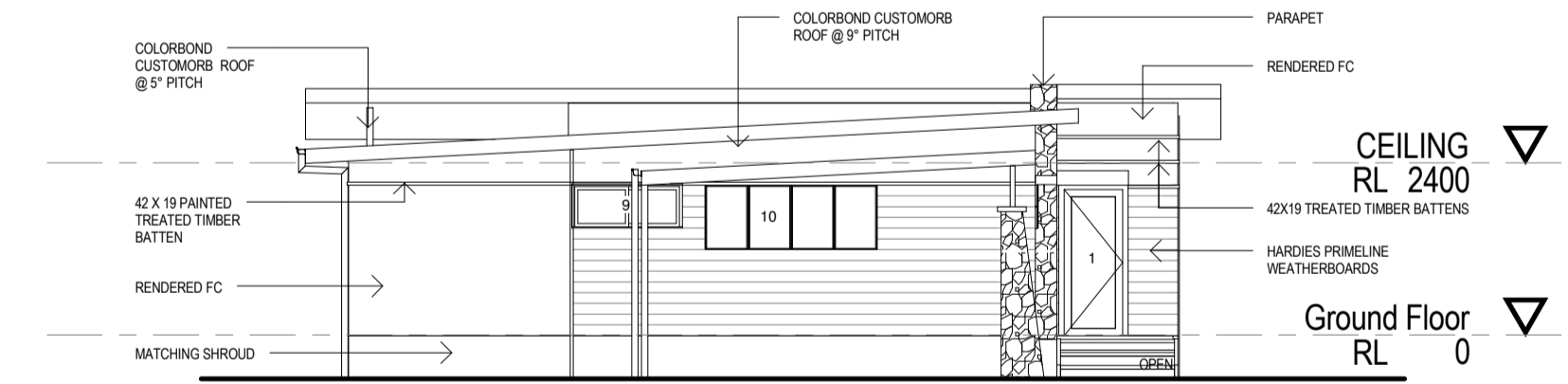
7 NORTH ELEVATION

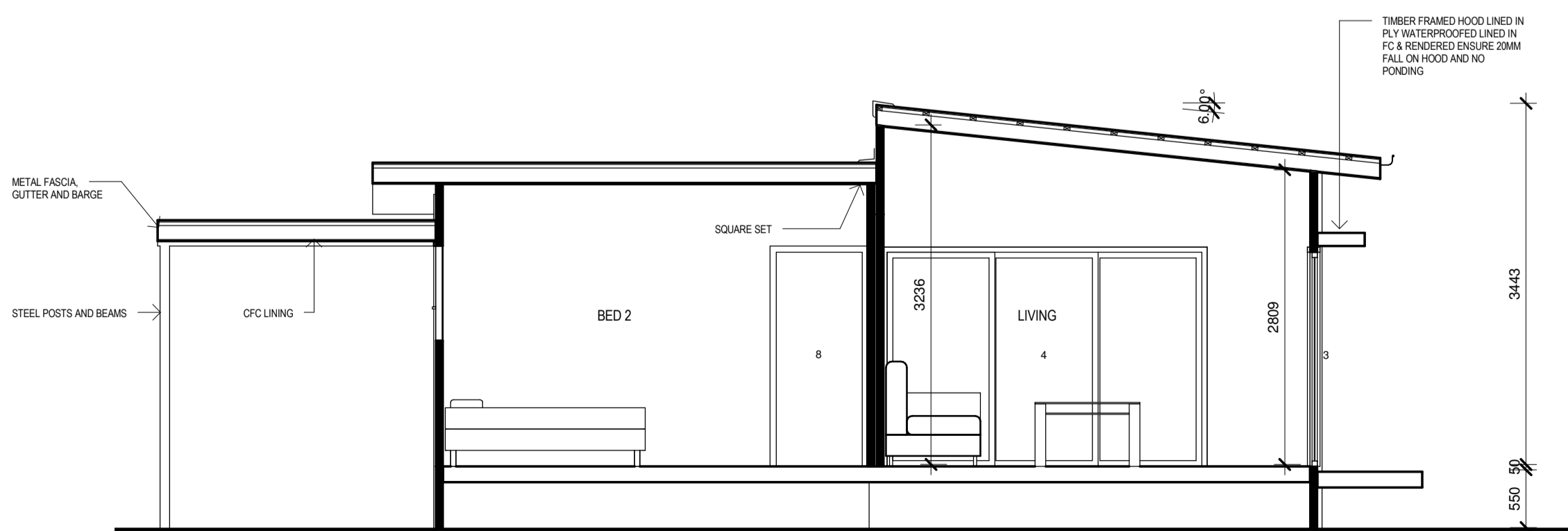
5 EAST ELEVATION
